Eindhoven, Netherlands, July 24, 2017 - NXP Semiconductors N.V. (NASDAQ: NXPI) announced today that, effective August 6, 2017, Chief Financial Officer Daniel Durn is leaving the company to become the Chief Financial Officer of Applied Materials, Inc.
