EXPLANATORY NOTE

This Amendment No. 2 (Amendment No. 2) amends and supplements the Tender Offer Statement on the Schedule TO initially filed with the Securities and Exchange Commission (the SEC) on January 14, 2019 as amended by Amendment No. 1 to the Schedule TO filed with the SEC on February 13, 2019 (as amended hereby, the Schedule TO) by Nuveen Taxable Municipal Income Fund, a diversified, closed-end management investment company organized as a Massachusetts business trust (the Fund), pursuant to Rule 13e-4 under the Securities and Exchange Act of 1934, as amended (the Exchange Act), in connection with the Fund s offer to purchase for cash up to 20% or 6,838,973 shares of the Fund s issued and outstanding common shares of beneficial interest, par value \$0.01 per share, upon the terms and subject to conditions contained in the Offer to Purchase dated January 14, 2019 (the Offer to Purchase) and the related Letter of Transmittal (the Letter of Transmittal , which together with the Offer to Purchase and any amendments or supplements to either or both, constitute the Offer), at a purchase price equal to 100% of the Fund s net asset value per share (NAV) determined as of February 12, 2019 at the close of ordinary trading on the New York Stock Exchange. The price that shareholders will receive will be net of a repurchase fee of \$0.0261 per share. Filed herewith as Exhibit (a)(5)(v) is a copy of the Press Release issued by the Fund on February 19, 2019 announcing the final results of the Offer, and the information contained therein is incorporated by reference.

This Amendment No. 2 to Schedule TO is intended to satisfy the requirements pursuant to Rule 13e-4(c)(3) of the Exchange Act.
