Item 8.01 Other Events

On September 3, 2014 our Board of Directors declared a quarterly dividend of \$0.30 per common share. The record dates for the dividend is September 26, 2014 and the payment date is October 9, 2014. Under the dividend policy updated December 4, 2013, our Board of Directors anticipates a total annual dividend of \$1.20 per share, to be paid in equal quarterly installments. However, any decision to pay future cash dividends will be subject to the Board's final determination after a comprehensive review of the company's financial performance, future expectations and other factors deemed relevant by the Board.
