Each RSU is equal to one share of Common Stock and vested upon the completion of three years of continuous employment. Vesting of 116 shares reduced by withholding of 28 shares to cover tax liability resulting from the maturation of this award.

If a participant terminates employment more than twelve months but less than three years from the date of grant, the RSUs will partially vest based on the number of days that the participant was employed in the vesting period. Any RSUs that are unvested on termination of employment will be forfeited. In addition, if a participant withdraws shares purchased for his or her account, matching unvested RSUs will be forfeited.
