- (1) Reporting Person was granted 6,890 restricted shares of common stock on March 5, 2007 under the issuer's 2004 Incentive Stock Plan. The shares vest as to 50% of the total on December 31, 2009 and 50% of the total on December 31, 2010. The issuer withheld 1,826 shares as payment of Reporting Person's income tax withholding in connection with the award amount that vested on December 31, 2009. Computation of the number of shares withheld for payment of tax was based upon the closing price of issuer's stock on the vesting date.
- (2) Reporting Person was granted 3,273 restricted shares of common stock on February 25, 2008 under the issuer's 2004 Incentive Stock Plan. The shares vest as to 33-1/3% of the total immediately, 33-1/3% of the total on December 31, 2008, and 33-1/3% of the total on December 31, 2009. The issuer withheld 578 shares as payment of Reporting Person's income tax withholding in connection with the award amount that vested on December 31, 2009. Computation of the number of shares withheld for payment of tax was based upon the closing price of issuer's stock on the vesting date.
- (3) Reporting Person was granted 5,065 restricted shares of common stock on February 25, 2009 under the issuer's 2004 Incentive Stock Plan. The shares vest as to 33-1/3% of the total immediately, 33-1/3% of the total on December 31, 2009, and 33-1/3% of the total on December 31, 2010. The issuer withheld 895 shares as payment of Reporting Person's income tax withholding in connection with the award amount that vested on December 31, 2009. Computation of the number of shares withheld for payment of tax was based upon the closing price of issuer's stock on the vesting date.
