Represents 17,071 shares of the issuer's common stock underlying restricted stock units granted to the reporting person under the issuer's Long-Term Incentive Plan. The units will vest in three successive annual installments upon the reporting person's completion of each year of service with the issuer over the three-year period measured from January 1, 2015, subject to accelerated vesting under certain prescribed circumstances.
