On April 15, 2018, the Reporting Person was awarded a total of 2,392 restricted share units (RSUs) pursuant to the terms of the Issuer's (1) Share Election Program as approved by Issuer's Board of Directors and Shareholders on 7/24/2013 and 7/29/2013, respectively. The award was granted for the quarterly period from 1/1/2018 to 3/31/2018. The award vested immediately upon grant.
