(1) On October 1, 2018, the common stock of Neonode Inc. underwent a 1-for-10 reverse split, resulting in the reporting person's ownership of 750,000 shares of common stock immediately prior to the reverse split being converted into 75,000 shares of common stock immediately after the reverse split.

(2) Reflects a change in form of indirect ownership since previous beneficial ownership statement on Form 3 due to a distribution to A.B. Aniara Ltd from its subsidiary Merkatūra AB of 75,000 shares of Neonode common stock. Mr. Bunge is the 100% beneficial owner of both A.B. Aniara Ltd and Merkatūra AB.
