Intrepid Mining dissolved on April 25, 2008, and distributed its assets proportionately to its members, as a result of which Intrepid Production Corporation ("IPC") became the direct beneficial owner of 16,136,000 shares of common stock. IPC is wholly-owned by Mr. Jornayvaz.
