The Reporting Person was granted 22,938 shares of Deferred Common Stock under the 2013 Stock-Based Compensation Plan. 7,994 time-vested deferred shares vest over a three year period as follows: 2,665 time-vested deferred shares on January 7, 2020 and 2021, respectively, and 2,664 time-vested deferred shares on January 7, 2022. 6,950 performance-based deferred shares are targeted to vest on

- (1) January 7, 2022 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance-based vested shares varying from 0 to 200% of 6,950. 7,994 performance-based deferred shares are targeted to vest on January 7, 2022 based on the Return on Invested Capital achieved by the Company compared to the ROIC target, with the final number of performance-based vested shares varying from 0 to 200% of 7,994.
