Item 1.01 Entry into a Material Definitive Agreement.

On April 9, 2008, the Registrant received executed Contract No. C022813, between the New York State Department of Health and WellCare of New York, Inc., a wholly-owned subsidiary of the Registrant ("WellCare NY"), pursuant to which WellCare NY participates in the New York State Child Health Plus Program. Under the contract, WellCare NY will continue to provide managed care services to individuals eligible for the Child Health Plus program in the counties of Albany, Bronx, Columbia, Dutchess, Greene, Kings, New York, Orange, Queens, Rensselaer, Rockland and Ulster. The contract is effective January 1, 2008 through December 31, 2012. A copy of the contract is attached as Exhibit 10.1 to this Current Report on Form 8-K.

The foregoing description does not purport to be a complete statement of the parties' rights and obligations under the above-described contract. The above description is qualified in its entirety by reference to the contract.
