### **Clarification on the Share Split**

(Rio de Janeiro, March 5, 2008). PETRÓLEO BRASILEIRO S/A - PETROBRAS, [Bovespa: PETR3/PETR4, NYSE: PBR/PBRA, Latibex: XPBR/XPBRA, BCBA: APBR/APBRA], a Brazilian international energy company, in response to Bovespa written notice GAE/SRE 383/08, clarifies that:

- a) The date that is foreseen for the credit for the stock resulting from the split will be that of the closing bell of 04/25/2008, therefore the ex-rights date will be 04/28/2008; and
- b) The stock derived from the split will participate, in equal conditions, in all benefits, including dividends and possible capital payments Petrobras may distribute.
