### **Start up of the pre-salt oil refining**

Rio de Janeiro, July 02, 2009 PETRÓLEO BRASILEIRO S/A - PETROBRAS, informs that, on June 30, it started up at Capuava Refinery (Recap) the refining of the first oil from Tupi field, located at the pre-salt area of Santos Basin.

The oil, offloaded from Tupi Extend Well Test (EWT) production system, presented the following characteristics: gravity of 28.5° API, low sulfur and low acidity.

The start of this process will be relevant to evaluate the quality and potentiality of the oil products produced using the pre-salt oil.
