### **Clarification on Public Share Offering**

Rio de Janeiro, August 2 2010   Petróleo Brasileiro S.A. - Petrobras clarifies the information published yesterday by the Folha de São Paulo newspaper in an article entitled "Petrobras wants to make a public offering on the stock exchange" which stated that "Petrobras redesigned its capitalization. The equity offering, initially restricted to existing shareholders, is likely to be modeled as a global offering, open to all interested parties in Brazil and the world".

The Company reaffirms its intention of carrying out the capitalization through a public equity offering with priority allocation rights to current shareholders by September of this year, as stated the Press Release issued on April 30, 2010 and filed with the Securities and Exchange Commission - CVM and other markets where Petrobras trades its shares.

Not only is the information provided by the newspaper article distorted and incorrect, as Petrobras intends to give priority rights to current shareholders through a priority allocation, but the information is not aligned with the Press Release issued by the Company and referred above.

Petrobras reasserts that it is in a quiet period, as required by CVM Instruction 400/03, article 48, until a public announcement that the public offering has been concluded is made. However, it emphasizes to its shareholders that official information on the development of this transaction is disclosed solely by the Company.

Thus, the Company also does not confirm any other information disseminated by the press in general and informs that any comments on the amount of the intended public offering and details about the structure and implementation schedule are mere speculation.

This announcement is not an offer of Petrobras shares. Petrobras shares may not be offered or sold in the United States absent registration or an exemption from registration, and Petrobras currently intends to register the proposed offering in the United States. Any public offering of Petrobras shares will be made by means of a prospectus containing detailed information about Petrobras and the offering.
