EXPLANATORY NOTE

This Amendment to the Annual Report on Form 10-K (the "Amendment") of Education Realty Trust, Inc. (the "Company") amends the Company's Annual Report on Form 10-K for the year ended December 31, 2013 (the "2013 Annual Report"), which was filed with the Securities and Exchange Commission on March 3, 2014.

The Company is filing this Amendment to its 2013 Annual Report to include an exhibit in accordance with Rule 3-09 of Regulation S-X with the financial statements of University Village- Greensboro, LLC ("UV- Greensboro"), an unconsolidated joint venture affiliate of the Company. Although the consent of the independent auditors was included in the original 2013 Annual Report filing, the financial statements were inadvertently omitted. This Amendment does not affect any other items in the 2013 Annual Report.

This Amendment to the 2013 Annual Report is being filed solely to include the separate financial statements of UV-Greensboro as provided in Exhibit 99.1 attached hereto and the consent from the independent auditor, Dixon Hughes Goodman LLP, filed as Exhibit 23.2. In addition, in connection with the filing of this Amendment to the 2013 Annual Report and pursuant to Rule 12b-15 of the Securities Exchange Act of 1934, as amended, the currently dated certifications of the principal executive officer and principal financial officer of the Company are attached as exhibits hereto.

Item 15 is the only portion of the 2013 Annual Report being supplemented or amended by this Amendment to the 2013 Annual Report. Except as described above, this Amendment to the 2013 Annual Report does not amend, update or change the financial statements or any other items or disclosures contained in the 2013 Annual Report and does not otherwise reflect events occurring after the original filing date of the 2013 Annual Report. Accordingly, this Amendment to the 2013 Annual Report should be read in conjunction with the Company's filings with the SEC subsequent to the filing of the 2013 Annual Report.
