Today, TELEFÓNICA, S.A., through its wholly- owned subsidiary TELEFÓNICA EMISIONES, S.A.U., under its *Guaranteed Euro Medium Term Note Programme (EMTN Programme)* filed with the *Financial Services Authority (FSA)* in London on July 3<sup>rd</sup>, 2008, has launched an issue of Notes guaranteed by TELEFÓNICA, S.A. in the Euro market amounting 1,000 million euros.

This seven (7) year Notes pays an annual coupon of 5.496% and has a reoffer price of 100%. Settlement and closing date is scheduled for execution on April 1<sup>st</sup>, 2009.
