Item 7.01. Regulation FD Disclosure.

On October 23, 2014, Blueknight Energy Partners, L.P. (the “Partnership”) issued a press release (the “Press Release”) announcing that on November 14, 2014 it will pay quarterly distributions of \$0.1345 per common unit, a 1.5% increase over the previous quarter’s distribution and a 9.8% increase over the third quarter of 2013’s distribution, and \$0.17875 per preferred unit to its common and preferred unitholders of record as of the close of business on November 4, 2014. A copy of the Press Release is furnished as an exhibit to this Current Report.
