### Claims Proceeds Investment Agreement Amendment

On December 28, 2017, Brickell Key Investments LP, (<u>"Brickell"</u>), a special purpose fund under the management of Brickell Key Asset Management Limited, a Guernsey-based asset manager amended the Claims Proceeds Investment Agreement (the "Agreement") between Brickell and the Company, dated February 25, 2016, as amended on May 27, 2016, to provide an additional \$1 million to the Company ("Additional Funds") to be used to pay the Company's legal fees and expenses in connection with its German patent assertion program. The Agreement amendment also provides that the Company will repay and compensate Brickell for the Additional Funds on substantially the same terms and conditions set forth in the Agreement as disclosed under Item 1.01 of the Company's Current Report on Form 8-K filed on February 26, 2016 and incorporated herein by reference.
