BKF Holdings owns 779,419 shares of Qualstar. BKF Capital may be deemed the beneficial owner of 2,855,120 shares of Qualstar, consisting of 2,075,701 shares owned directly by BKF Capital, and an additional 779,419 shares owned through BKF Holdings. Steven N. Bronson, as the Chairman, CEO and majority shareholder of BKF Capital, may be deemed to be the beneficial owner of the shares of Qualstar held by BKF Capital. Steven N. Bronson is the owner and an additional 57,700 shares of Qualstar.
 - (2) BKF Holdings owns 784,533 shares of Qualstar. BKF Capital may be deemed the beneficial owner of 2,860,234 shares of Qualstar, consisting of 2,075,701 shares owned directly by BKF Capital, and an additional 784,533 shares owned through BKF Holdings.
