  - (1) The Reporting Person is a managing director of Goldman, Sachs & Co. ("Goldman Sachs"). Goldman Sachs is a wholly-owned subsidiary of The Goldman Sachs Group, Inc. ("GS Group"). The Reporting Person disclaims beneficial ownership of the securities reported herein except to the extent of his pecuniary interest therein, if any.
  - (2) Effective November 28, 2008, the Reporting Person resigned from the Board of Directors of Validus Holdings, Ltd. (the "Company"). Goldman Sachs and GS Group may be deemed to beneficially own indirectly, in the aggregate, 14,057,137 common shares of the Company, par value \$ 0.175 per share (the "Common Shares") and 1,604,410.1 warrants to purchase Common Shares by reason of the beneficial ownership of such shares by certain investment partnerships of which affiliates of Goldman Sachs and GS Group are the general partner, managing general partner or managing limited partner.
  - (4) The warrants are exercisable at any time prior to December 12, 2015.
