**Teva Announces Appellate Court Reverses Generic Risperdal<sup>®</sup> Exclusivity Decision**

**Jerusalem, Israel, September 14, 2008** - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today that following a hearing on September 12, 2008, the U.S. Court of Appeals for the District of Columbia has vacated an April 2008 ruling, which granted Teva 180-day exclusivity for its Risperidone Tablets, AB-rated to Janssen's Risperdal<sup>®</sup> Tablets. As a result of this decision, the U.S. Food and Drug Administration is no longer enjoined from approving subsequent Abbreviated New Drug Applications (ANDA).

Teva intends to seek a stay of this decision pending further appeals.
