**FEDERAL CIRCUIT AFFIRMS DENIAL OF PRELIMINARY INJUNCTION REGARDING TEVA'S  
GENERIC PROTONIX® TABLETS**

**Jerusalem, Israel, May 14, 2009** - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today that the U.S. Court of Appeals for the Federal Circuit unanimously affirmed a September 2007 ruling, which denied a motion filed by Wyeth and Altana for a preliminary injunction related to Teva's Pantoprazole Sodium Delayed Release (DR) Tablets, AB-rated to Wyeth's Protonix® DR Tablets.

Teva is currently involved in patent litigation with Wyeth and Altana concerning this product. A trial date has not been set.
