**ITEM 3.03 Material Modifications to Rights of Security Shareholders**

On November 14, 2007, the Board of Directors of Atwood Oceanics, Inc. (the “Company”) approved the Atwood Oceanics, Inc. Nonemployee Directors’ Elective Deferred Compensation Plan (the “Plan”). The purpose of the Plan is to provide nonemployee directors of the Company with an opportunity to defer compensation earned as a director. A nonemployee director may defer all or a specified percentage of such compensation. The nonemployee directors may defer both restricted stock awards and the cash retainer payable annually for service as a Company director. The total compensation received by the nonemployee directors is not affected by the Plan. The Plan becomes effective on December 1, 2007.

This summary description of the Plan does not purport to be complete and is qualified in its entirety by reference to the Plan, which is attached as Exhibit 10.1 and incorporated herein by reference.
