Remarks:

On April 20, 2006, Mr. Ward entered into a forward sale agreement (the "Agreement") relating to up to 2,813,854 shares (the "Shares") of the common stock of the Company (the "Company").

(a) If the closing price of the common stock on April 20, 2007 (the "Settlement Price") is less than or equal to \$27.9683 (the "Hedged Value"), the Settlement Ratio will be equal to the sum of the Hedged Value and the Upside Limit.

(b) If the Settlement Price is greater than the Hedged Value but less than \$42.3309 (the "Upside Limit"), the Settlement Ratio will be equal to the sum of the Hedged Value and the Settlement Price.

(c) If the Settlement Price is equal to or greater than the Upside Limit, the Settlement Ratio will be equal to the sum of the Hedged Value and the Settlement Price.

In consideration therefore, the Agreement provides that Mr. Ward will receive a purchase price of \$74,669,378.78.
