This Amendment No. 54 to Schedule 14D-9 amends and supplements the Solicitation/Recommendation Statement on Schedule 14D-9 (as amended from time to time, the Statement ) originally filed by Airgas, Inc., a Delaware corporation ( Airgas or the Company ), with the Securities and Exchange Commission on February 22, 2010, relating to the tender offer by Air Products Distribution, Inc. ( AP Sub ), a Delaware corporation and wholly owned subsidiary of Air Products and Chemicals, Inc. ( Air Products ), to purchase all of the outstanding shares of Airgas Common Stock, par value \$0.01 per share, including the associated rights to purchase shares of Series C Junior Participating Preferred Stock ( Rights, and together with the Airgas Common Stock, the Airgas Common Shares ), at a price of \$65.50 per share, net to the seller in cash, without interest and less any required withholding taxes.
