This Form 4 reports the grant of 13,125 shares of restricted stock under the Spartan Stores, Inc. 2001 Stock Incentive Plan ("Plan"). These

(1) shares will vest at the rate of 20% each year beginning on May 11, 2005, and will be fully vested on May 11, 2010. Prior to vesting, these shares will remain subject to restrictions in accordance with the Plan and the terms of the grant.

(2) The reporting person also owns 2,186.348 shares of common stock indirectly through a 401(k) Plan.
