 - (ii) (iii) Mr. Maltese directly owned no shares of Common Stock. By reason of his position as Managing Member of MCM, Mr. Maltese may be deemed to beneficially own 1,550,500 shares of Common Stock, constituting approximately 6.76% of the shares outstanding.
