Pursuant to the KSOP, participants in the ESOP portion are entitled to instruct the plan trustee as to the voting of the shares allocated to their ESOP accounts. On each issue with respect to which shareholders are entitled to vote, the KSOP trustee is required to vote the shares held by the ESOP portion which have not been allocated to participant accounts in the manner directed under the KSOP.
