This Amendment No. 1 to the Schedule 13G (this Amendment ) is being filed on behalf of Fir Tree Value Master Fund, L.P., a Cayman Islands exempted limited partnership ( Fir Tree Value ), and Fir Tree, Inc., a New York corporation ( Fir Tree ), relating to Class A Common Stock, \$.01 par value (the Common Stock ), issued by Clear Channel Outdoor Holdings, Inc., a Delaware corporation (the Issuer ), purchased by Fir Tree Value. Fir Tree is the investment manager of Fir Tree Value. Fir Tree Value and Fir Tree are collectively referred to herein as the Reporting Persons.

- (a) Fir Tree Value is the beneficial owner of 1,004,270 shares of Common Stock. Fir Tree may be deemed to beneficially own the shares of Common Stock held by Fir Tree Value as a result of being the investment manager of Fir Tree Value.
- (b) The Reporting Persons beneficially own 1,004,270 shares of Common Stock, which represents approximately 2.5% of the Common Stock outstanding. This percentage is determined by dividing the number of shares of Common Stock beneficially held by the Reporting Persons, by 40,887,612, the number of Shares issued and outstanding as of October 31, 2010, as reported in the Issuer's Form 10-Q filed with the Securities and Exchange Commission on November 8, 2010.
- (c) Fir Tree Value may direct the vote and disposition of 1,004,270 shares of Common Stock. Fir Tree has been granted investment discretion over the Common Stock held by Fir Tree Value, and thus, has the shared power to direct the vote and disposition of 1,004,270 shares of Common Stock.
