- (1) In accordance with the Hemisphere Media Group, Inc. (the "Company") Amended and Restated 2013 Equity Incentive Plan (the "Plan"), the Reporting Person returned shares of the Company's Class A common stock to the Company for the purpose of paying the Reporting Person's withholding taxes due upon the vesting of restricted shares of Class A common stock previously awarded to the Reporting Person under the Plan. The disposition is exempt in accordance with Rule 16b-3.
  - (2) The fair market value of the Class A common stock at the close of trading on August 5, 2016, the last trading day prior to August 7, 2016, the date of vesting, was used to calculate the number of shares deducted to satisfy the Reporting Person's tax withholding obligations.
  - (3) Of these shares, 16,666 shares of Class A common stock are restricted securities and will vest, subject to certain exceptions, in equal annual installments on the second and third anniversary of August 7, 2015.
