4/7/15: The Federal Energy Regulatory Commission (FERC) today issued an order approving Wisconsin Energy Corporation’s proposed acquisition of Integrys Energy Group, Inc. This is an important milestone toward completing the transaction.

The acquisition still requires the approval of the public service commissions of Illinois, Michigan, Minnesota and Wisconsin which are expected to make their decisions beginning in late April, through early July.

In connection with the proposed merger transaction between Wisconsin Energy Corporation (“Wisconsin Energy”) and Integrys, Wisconsin Energy filed with the Securities and Exchange Commission (the “SEC”) a registration statement on Form S-4 that includes a joint proxy statement/prospectus for the shareholders of Wisconsin Energy and Integrys. The registration statement was declared effective by the SEC on October 6, 2014. Each of Wisconsin Energy and Integrys mailed the joint proxy statement/prospectus to their respective shareholders on or around October 21, 2014 and filed other documents regarding the proposed merger transaction with the SEC. Integrys urges investors and shareholders to read the joint proxy statement/prospectus, as well as other documents filed with the SEC, because they contain important information.
