(1) (Tech II), respectively 1,006,133 shares of Common Stock are held by QP, 781,108 shares of Common Stock and 350,000 Wts are held by Cayman, 1,608,588 shares of Common Stock and 750,000 Wts are held by PE, 223,800 shares of Common Stock and 105,000 Wts are held by Tech and 1,380,900 shares of Common Stock and 645,000 Wts are held by Tech II. The interest of Marxe and Greenhouse in the shares of Common Stock owned by QP, Cayman, PE, Tech, and Tech II is limited to the extent of his pecuniary interest.
