On March 18, 2015, KKR Group Finance Co. III LLC (the <u>Issuer</u>), an indirect subsidiary of KKR & Co. L.P. (the <u>Partnership</u>) completed the offering of an additional \$500,000,000 aggregate principal amount of its 5.125% Senior Notes due 2044 (the <u>Notes</u>). The Notes are guaranteed by the Partnership, KKR Management Holdings L.P., KKR Fund Holdings L.P. and KKR International Holdings L.P., each indirect subsidiaries of the Partnership (collectively with the Partnership, the <u>Guarantors</u>). The Notes were issued pursuant to an indenture (the <u>Base Indenture</u>) dated May 29, 2014, as supplemented by a first supplemental indenture, dated May 29, 2014 (the <u>First Supplemental Indenture</u>) and a second supplemental indenture, dated August 5, 2014 (the <u>Second Supplemental Indenture</u> and, together with the Base Indenture and the First Supplemental Indenture (the <u>Indenture</u>) with The Bank of New York Mellon Trust Company, N. A., as trustee (the <u>Trustee</u>).

The Notes constitute an additional issuance of the Issuer s 5.125% Senior Notes due 2044, \$500 million aggregate principal amount of which were previously issued and are outstanding (the <u>Existing Notes</u>). The Notes form a single series with the previously issued notes.

The Notes bear interest at a rate of 5.125% per annum, accruing from December 1, 2014. Interest is payable semiannually in arrears on June 1 and December 1 of each year, commencing on June 1, 2015. The Notes will mature on June 1, 2044, unless earlier redeemed or repurchased. The Notes are unsecured and unsubordinated obligations of the Issuer. The Notes are fully and unconditionally guaranteed (the <u>Guarantees</u>), jointly and severally, by each of the Guarantors. The Guarantees are unsecured and unsubordinated obligations of the Several Several

The Indenture includes covenants, including limitations on the Issuer s and the Guarantors ability to, subject to exceptions, incur indebtedness secured by liens on voting stock or profit participating equity interests of their subsidiaries or merge, consolidate or sell, transfer or lease assets. The Indenture also provides for events of default and further provides that the Trustee or the holders of not less than 25% in aggregate principal amount of the outstanding Notes and Existing Notes may declare the Notes immediately due and payable upon the occurrence and during the continuance of any event of default after expiration of any applicable grace period. In the case of specified events of bankruptcy, insolvency, receivership or reorganization, the principal amount of the Notes and any accrued and unpaid interest on the Notes automatically become due and payable. The Issuer may redeem the Notes in whole or in part, at any time and from time to time, prior to their stated maturity at the redemption prices set forth in the Notes. If a change of control repurchase event occurs, the Notes are subject to repurchase by the Issuer at a repurchase price in cash equal to 101% of the aggregate principal amount of the Notes repurchased plus any accrued and unpaid interest on the Notes repurchased to, but not including, the date of repurchase.


