Item 2.03. Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant.

On November 23, 2016, Virtusa Corporation (the Company) purchased multiple foreign currency forward contracts designed to hedge fluctuation in the Indian rupee against the U.S. dollar and U.K. pound sterling. The U.S dollar contracts have an aggregate notional amount of approximately 727,800,000 Indian rupees (approximately \$10,138,000) and have an average settlement rate of 71.83 Indian rupees. The U.K. pound sterling contracts have an aggregate notional amount of approximately 268,161,000 Indian rupees (approximately £3,014,000) and have an average settlement rate of 89.01 Indian rupees. These contracts will expire at various dates during the 17 month period ending on March 31, 2018. The Company will be obligated to settle these contracts based upon the Reserve Bank of India published Indian rupee exchange rates. Based on the U.S. dollar to U.K. pound sterling spot rate on November 23, 2016 of \$1.25, the blended weighted average Indian rupee rate associated with both the U.S. dollar and U.K. pound sterling contracts would be approximately 71.69 Indian rupees per U.S. dollar.
