This prospectus supplement updates information in the "Selling Stockholders" section of such prospectus and, accordingly, to the extent inconsistent, the information in this prospectus supplement supersedes the information contained in such prospectus. This prospectus supplement may not be delivered or utilized without such prospectus. This prospectus supplement is qualified by reference to such prospectus, except to the extent that the information in this prospectus supplement supersedes the information contained in such prospectus.

Our common stock is listed on the New York Stock Exchange under the symbol "LSE." On November 12, 2008, the last reported sale price of our common stock on the New York Stock Exchange was \$4.12 per share.
