On July 26, 2017 (the "Closing"), FIMI IV 2007, FIMI ENRG 1, FIMI ENRG 2 and Ishay Davidi (the "FIMI Entities") sold all of their shares of common stock, par value \$0.001
- (1) per share ("Shares") of the Issuer to Orix Corporation ("Orix"). Prior to the Closing, FIMI ENRG 1 and FIMI ENRG 2 exercised the call option granted to them and purchased from Bronicki Investments Ltd. an aggregate of 203,528 Shares of the Issuer. In addition, prior to the Closing, FIMI ENRG 2 purchased from Mr. Gillon Beck and Mr. Ami Boehm an aggregate of 75,000 Shares of the Issuer. All such Shares were sold by FIMI ENRG 1 and FIMI ENRG 2, as applicable, to Orix.
