On December 5, 2006, the reporting person was granted: (i) 15,000 restricted shares of common stock pursuant to the 2000 Employee Stock Option Plan of Mack-Cali Realty Corporation, which shares shall be fully vested upon issuance and shall be subject to a six month restriction on transfer, and (ii) 8,222 restricted shares of common stock pursuant to the 2000 Employee Stock Option Plan of Mack-Cali Realty Corporation, which shares shall vest in two, equal, annual installments on January 1, 2007 and January 1, 2008, and solely with respect to the shares that will vest on January 1, 2007, shall be subject to a six month restriction on transfer.
