- (1) On July 9, 2007, the reporting person was granted an option to exercise 15,500 shares of common stock. The option vests equally in three annual installments beginning on July 9, 2008.

- (2) On October 30, 2007, the reporting person was granted an option to exercise 12,000 shares of common stock. The option vests equally in three annual installments beginning on October 30, 2008.
- (3) On April 14, 2008, the reporting person was granted 8,500 shares of Common Stock pursuant to a Restricted Stock Agreement. The shares are subject to forfeiture and are scheduled to vest on April 14, 2011 pursuant to the terms of the Restricted Stock Agreement.
On April 14, 2008, the reporting person was granted 12,750 shares of Common Stock pursuant to a Restricted Stock Agreement. The shares are subject to forfeiture based on pre-determined corporate financial performance criteria for fiscal year 2009. Following the completion of fiscal 2009, a determination will be made as to whether the performance-based restrictions lapse as to some or all of the Restricted Stock. To the extent that the performance-based restrictions lapse, then the shares vest as follows: (i) one-third as of the date the performance-based restrictions lapse and (ii) one-third each on April 14, 2010 and April 14, 2011.
- (4) On April 14, 2008, the reporting person was granted an option to exercise 25,500 shares of Common Stock. The option vests equally in three annual installments beginning on April 14, 2009.
