Mr. Jarvis disclaims beneficial ownership of the depositary receipts held directly by MRESOF, except to the extent of the pecuniary interest, if any, in such depositary receipts as a result of his membership interest in Advisors, which has a contingent right to receive a performance-based advisory fee from MRESOF.
