Such securities were acquired (a) in connection with the contribution by certain affiliates of the Farallon Funds to Hudson Pacific Properties, L.P., a Maryland limited partnership (the "Operating Partnership") of which the Issuer is the sole general partner, of their ownership interests in certain real property-owning entities or (b) in a private placement concurrent with the Issuer's initial public offering at the initial public offering price of \$17 per share.
