Item 3. Source and Amount of Funds or Other Consideration.

The total amount of funds required by the Reporting Persons to acquire the Depository Receipts was \$10,021,132.00. Each of the Funds used its own assets to purchase such Depository Receipts, which may at any given time include funds borrowed in the ordinary course in their margin accounts.
