### Item 5.03 Amendments to Articles of Incorporation or By-laws; Change in Fiscal Year.

Effective December 13, 2007, the Board of Directors (the Board ) of Westinghouse Air Brake Technologies Corporation (the Company ) approved certain changes to the Company s By-laws to allow the Company to issue shares of stock in the Company in either certificated or uncertificated form. The changes to the By-laws include:

Article V Stock

Amended <u>Section 1</u> to allow shares of stock of the Company to either be represented by certificates or to be uncertificated, to the extent described in <u>Section 5</u> and <u>Section 6</u> (as discussed below).

Revised Section 3 to allow the Company to issue a new certificate of stock or uncertificated shares in the place of any certificate previously issued by it that is alleged to have been lost, stolen or destroyed.

Eliminated from <u>Section 4</u> the requirement that the Company issue a new certificate upon transfer of a certificate. Amended <u>Section 4</u> to include a provision regarding the transfer of uncertificated shares.

Added a new <u>Section 5</u> to allow all or part of the shares of stock of the Company to be uncertificated to the extent determined by the Board from time to time. In no event, however, will shares represented by a certificate be deemed uncertificated until the certificate is surrendered to the Company.

Added a new Section 6 to allow the Board (or an officer or other person designated by the Board) from time to time to make rules, policies and procedures as it, he or she may deem appropriate concerning the issue, transfer and registration of shares of stock of the Company, whether certificated or uncertificated.

Moved the original <u>Section 5</u> entitled Record Date to a new <u>Section 7</u>.

Moved the original <u>Section 6</u> entitled Beneficial Owners to a new <u>Section 8</u>.
