Explanatory Statement

On August 3, 2007, Chordiant Software, Inc., a Delaware corporation (the Registrant), filed a Registration Statement on Form S-8 (File No. 333-145080) (the Registration Statement), which registered 1,600,000 shares of the Registrant's common stock, par value \$0.001 per share (the Common Stock) reserved for issuance under the 2005 Equity Incentive Plan (the 2005 Plan).
