# EXPLANATORY NOTE

At the 2016 annual meeting of stockholders of Evercore Partners Inc. (the Company ), the Company s stockholders approved the Amended and Restated 2016 Evercore Partners Inc. Stock Incentive Plan (the Plan ), which provides for grants of equity awards to designated employees, directors and other service providers of the Company and its affiliates. The number of shares of the Company s Class A common stock, par value \$0.01 (the Shares ) which may be granted under the Plan has been increased by 10,000,000 Shares from the 25,000,000 Shares which were previously authorized for issuance under the Amended and Restated 2006 Evercore Partners Inc. Stock Incentive Plan and the 2006 Evercore Partners Inc. Stock Incentive Plan. This Registration Statement on Form S-8 relates to the additional 10,000,000 Shares authorized for issuance under the Plan.

Pursuant to General Instruction E on Form S-8, the contents of the Registration Statement on Form S-8 with respect to the 2006 Evercore Partners Inc. Stock Incentive Plan (Registration No. 333-136506), filed with the Securities and Exchange Commission on August 11, 2006, including the information contained therein, are hereby incorporated by reference to this Registration Statement on Form S-8 (the Registration Statement ), except that the provisions contained in Part II of such earlier registration statement are modified as set forth in this Registration Statement.

attorneys fees) incurred by them as a result of suits brought against them in their capacity as a director or officer, if they acted in good faith and in a manner they reasonably believed to be in or not opposed to the Company s best interests, and, with respect to any criminal action or proceeding, if they had no reasonable cause to believe their conduct was unlawful; provided that no indemnification may be made against expenses in respect of any claim, issue or matter as to which they shall have been adjudged to be liable to the Company, unless and only to the extent that the court in which such action or suit was brought shall determine upon application that, despite the adjudication of liability but in view of all the circumstances of the case, they are fairly and reasonably entitled to indemnity for such expenses which the court shall deem proper. Any such indemnification may be made by the Company only as authorized in each specific case upon a determination by the stockholders, disinterested directors or independent legal counsel that indemnification is proper because the indemnitee has met the applicable standard of conduct.

The Company s certificate of incorporation provides that the Company will indemnify its directors and officers to the fullest extent permitted by law and that no director shall be liable for monetary damages to the Company or its stockholders for any breach of fiduciary duty, except to the extent provided by applicable law.

The Company currently maintains liability insurance for its directors and officers. Such insurance is available to the Company s directors and officers in accordance with its terms.
