#### **Item 7.01 Regulation FD Disclosure**

On October 10, 2018, CVS Health Corporation ( CVS Health ) and Aetna Inc. ( Aetna ) entered into a consent decree with the U.S. Department of Justice (the DOJ ) that allows CVS Health s proposed acquisition of Aetna (the CVS Health Transaction ) to proceed, provided Aetna agrees to sell its individual standalone Medicare Part D prescription drug plans. The consent decree is subject to the normal court approval process.

The transactions contemplated by the previously disclosed asset purchase agreement and related agreements between Aetna and a subsidiary of WellCare Health Plans, Inc. (collectively, the Divestiture ) satisfy the consent decree s divestiture requirement. Closing of the Divestiture is subject to the closing of the CVS Health Transaction, regulatory approvals and other customary closing conditions.

Under the consent decree, completion of the CVS Health Transaction may proceed prior to the effective date of the Divestiture. Completion of the CVS Health Transaction remains subject to certain state regulatory approvals required in connection with the acquisition, including approvals from certain state departments of insurance and similar regulators, and the satisfaction of all closing conditions. CVS Health and Aetna are working with the regulators in the remaining jurisdictions to obtain clearance for the CVS Health Transaction.

CVS Health continues to expect the CVS Health Transaction to close in the early part of the fourth quarter of 2018.
