## **Novo Nordisk A/S – Share repurchase programme**

**Bagsværd, Denmark, 8 April 2013** – On 31 January 2013 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission’s regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 3.0 billion in the period from 31 January 2013 to 29 April 2013.

Since the announcement as of 2 April 2013, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 19,879,329 treasury shares, corresponding to 3.5% of the share capital. The total amount of shares in the company is 560,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares for an amount up to DKK 14.0 billion during a 12 month period beginning 31 January 2013. As of 5 April 2013, Novo Nordisk has repurchased a total of 2,271,810 B shares equal to a transaction value of DKK 2,240,611,823.
