(2) The number of share equivalents reported was determined by dividing the dollar amount credited to the Reporting Person's account by \$26.24 (the closing price for Hanesbrands Inc. common stock on the valuation date of October 27, 2010).

(3) The balance is determined by dividing the value in the Reporting Person's account following the reported transaction by \$26.24 (the closing price for Hanesbrands common stock on the transaction date of October 27, 2010).
