(1) Effective as of November 17, 2017, Federated Premier Intermediate Municipal Income Fund, (the "Target Fund") was reorganized into Federated Premier Municipal Income Fund, (the "Acquiring Fund"). Pursuant to the Plan of Reorganization and Termination (the "Plan"), the Acquiring Fund, a Delaware statutory trust and closed-end investment company, will acquire all, of the Target Fund's assets in exchange for shares of the Acquiring Fund to be distributed pro rata by the Fund to its shareholders, in a complete liquidation and dissolution of the Target Fund (the "Reorganization"). In the Reorganization, Citibank N.A. received 1,847 Variable Rate Term Preferred Shares of the Acquiring Fund in exchange for its 1,847 Variable Rate Term Preferred Shares of the Target Fund.

(2) These shares are beneficially owned by Citibank, N.A. ("Citibank"). Citicorp is the sole stockholder of Citibank. Citigroup Inc. is the sole stockholder of Citicorp.
