- (1) Restricted Share Units ("RSU's"). Upon vesting the Reporting Person is entitled to receive one (1) ordinary share for each one (1) RSU.  
The RSU's will vest at a rate of one-fourth (1/4th) of the original number of ordinary shares on August 1, 2019, and the remaining thereafter at a rate of one-sixteenth (1/16th) of the original number of shares on the first day of each quarterly period of November, February, May and August commencing on November 1, 2019, with the last one-sixteenth (1/16th) of the original number of shares vesting on August 1, 2022, so long as Mr. Waldman continues to provide services to the Issuer.
- (2) Includes 173,500 unvested Restricted Share Units (RSU's). Upon vesting thereof, the Reporting Person is entitled to receive one (1) Ordinary Share for each one (1) RSU.
- (3) Shares held by Waldo Holdings 2, a general partnership formed pursuant to the laws of Israel of which Mr. Waldman is a general partner. Mr. Waldman has sole voting and dispositive power over all of the shares reported on this Form 4.
