The sole reason for the filing of this Form 4/A is to correct the number of vested shares returned to the Company for tax withholding purposes. The initial Form 4 reported the disposition of 1,011 shares. The correct figure was 916 shares. As a result of such correction,
- (2) the amount of securities disposed of and the number of securities beneficially owned following the transaction changed slightly. All other information contained on the original Form 4 was accurately reported.
- (3) Shares of restricted stock effectively repurchased by Company at \$75.73 per share to fund the beneficial owner's required tax withholding.
